1. CALL TO ORDER

The meeting was called to order by Mayor Todd at 6:32 p.m.

4. PRESENTATIONS

4.1 Melissa Francis, Program Manager, Leeds and Grenville Immigration Partnership.

Ms. Francis presented a PowerPoint presentation which outlined the role and function of the Leeds and Grenville Immigration Partnership. A copy of the presentation is held on file.

Discussion was held regarding the potential for increased immigration due to the recent US travel ban and the ongoing issue of immigrants not being able to enter into employment that matches their specialized skills. Further discussion was held regarding Prescott being more involved with the Leeds and Grenville Immigration Partnership. Staff was directed to bring back a report on this in the future.

8. TOURISM & HERITAGE

Councillor Laschinger spoke to the upcoming Heritage Week in Ontario occurring from February 20-26. He stated that he would be making a presentation at the February Council meeting on heritage in Prescott.

9. TRANSPORTATION & ENVIRONMENTAL SERVICES

Councillor McConnell spoke to the funds in the 2016 budget allocated for sidewalk repairs. He spoke to spending the complete 2016 and 2017 sidewalk repair budget amounts in 2017. Pierre Mercier, CAO, stated that this would be brought back at the next meeting with the capital budget.

10. PLANNING

Councillor Ostrander asked for an update on Wiser Hall. Mr. Mercier stated that correspondence had been received from the Ontario Municipal Board. No action had been taken by the developer and the OMB had given them until February 26, 2017 to obtain the required approvals. Mr. Mercier stated that the Town was working with the developer to get this deadline extended.

11. ECONOMIC DEVELOPMENT

Councillor Young spoke to the commencement of construction of the new Mr. Gas facility on King Street East.

Pierre Mercier, CAO, stated that this was a running action list that would be updated accordingly. Mayor Todd asked Committee members for possible additions. Councillor Jansman stated that she had sent staff additions to add to the list.

Dylan Dyson, Coast FM, asked about the accessibility requirement deadline for the arena. Mr. Mercier stated that the deadline had passed, but that many other municipalities were in the same situation. He added that improvements had been made and more were added in the 2017 capital plan.
