South Grenville Digital Main Street Resolution

- RECEIVED CONFIRMATION IN EARLY MARCH THAT DIGITAL MAIN STREET FUNDING WAS CONCLUDING MARCH 31ST
- COUNCIL PASSED THE FOLLOWING RESOLUTION:

Whereas the provincial Digital Main Street Program funding is scheduled to end March 31, 2024; and

Whereas the Digital Main Street Program is a provincially funded program focusing on assisting small businesses with the adoption of technology; and

Whereas Digital Main Street Program has assisted 85 businesses in Prescott and 129 in South Grenville which includes Township of Edwardsburg – Cardinal and Township of Augusta; a total of 59 Digital Transformation Grants have been distributed, including 40 to Prescott Businesses, representing a direct investment of \$100,000 into Prescott businesses and \$147,500 across South Grenville; and

This program has specifically benefited South Grenville municipalities including the Town of Prescott by providing assistance with both one-on-one support and webinars for grant application, website set up, e commerce set up, social media page creation, social media analysis & content creation.

Now therefore be it resolved that the Council of the Town of Prescott support the continuation of funding for this successful and important program; and

That a copy of this resolution be forwarded to the Premier Doug Ford, MPP Steve Clark, the Township of Edwardsburg-Cardinal, the Township of Augusta and all other municipalities in Leeds and Grenville.

The Community Activator stream is intended to fund high-impact placemaking projects. Placemaking can be:



Events and Activations

Community events of a short, limited or repeating duration intended to draw visitors or create a new local offering, helping position a specific geographic area as a hub of community and economic activity.



Community enhancements

Above grade improvements to a specific geographic area that will enhance its physical and visual appeal, draw people in and increase feelings of safety, connection and community enjoyment.



Streetscape Improvements

Projects that facilitate a focused, deliberate path to revitalizing or strengthening a downtown or commercial district's economy through intentional and creative placemaking.
