The fire and rescue service is one of the most diverse and challenging professions. It is this diversity that inspires most men and women to enter the service – both as volunteers and career employees. <u>Accident and Disability Insurance</u>: Volunteer firefighters are provided with an insurance policy by VFIS providing a limited number of accident and disability benefits. The details of the insurance are provided to firefighters at the beginning of their probationary period.

<u>Clothing</u>: Volunteer firefighters are supplied with personal protection clothing in accordance with the Occupational Health and Safety Act and Prescott Fire Department Policy. This includes Duty Gear and Dress Uniforms for public events and exercises.

### **Requirements:**

To be eligible for consideration as a volunteer firefighter with the Prescott Fire Department candidates must submit the attached "Volunteer Firefighter Application" and:

- Have a valid Ontario Driver's License
- Be a minimum age of 18 years old
- Physically able to perform tasks/duties of the job
- Able to commit to training and respond to emergency calls
- Have no conviction of a criminal offence related to the job duties of a firefighter
