### **Town of Prescott Official Plan Review**

**TAKE NOTICE** that the Town of Prescott invites all interested persons to attend a Public Open House in order to consider revisions and provide input on the Town's Draft Official Plan, pursuant to the requirements of Section 17(16) of the Planning Act, RSO 1990, as amended.

An **Official Plan** provides direction and policy objectives for the growth and development of the community and establishes where land uses (e.g. residential, commercial, and industrial) should be located. The Official Plan covers a broad range of topics including transportation, economic development, housing and future development opportunities. The Official Plan works in conjunction with other municipal planning documents, such as the Zoning By-law, to guide the patterns of development in the Town.

At the **Public Open House**, the Draft Official Plan will be available for review. Staff from the Town will be available to answer questions and obtain comments.

Attendees will also have the opportunity to participate in a small group discussion exercise known as a "World Café". During the World Café, attendees can provide input on these key topics:

- Active Transportation;
- Housing;
- Tourism, Economic Development and Downtown Revitalization; and
- Mixed-Use Development Opportunities South of Highway 401.

Following the exercise, attendees will be invited to share the insights from their discussions with the rest of the large group.

A children's activity table will be available during the event.

**PURPOSE AND EFFECT:** The Town of Prescott is undertaking the legislated review and update of its Official Plan as required by the Planning Act. The Town's current Official Plan was approved in 2006 and was last amended in May 2018. The Official Plan Review will update and refine the goals, objectives, policies, and schedules of the Official Plan to ensure that it is consistent with the 2020 Provincial Policy Statement and reflects matters of local interest. The proposed Official Plan will replace the existing Official Plan currently in effect.

**THE SUBJECT LANDS** include all lands located within the Town of Prescott municipal boundary. Accordingly, no key map is provided.
